

Robert Stitt QC

Robert Stitt QC is one of Australia's most senior Queen's Counsel.

He has acted in a wide range of matters including Royal Commissions and Boards of Enquiry, commercial litigation and arbitration, and defamation. He regularly appears for insurance companies in relation to major claims and commercial disputes, and is briefed by professional associations including the NSW Law Society, the NSW Bar Association, the Australian Dental Association and the Pharmacy Council in professional negligence and disciplinary proceedings. For many years he has acted for the Australian Jockey Club and the thoroughbred racing industry, most notably the horse "Choc Daley" doping investigation which reformed testing procedures, and the horse "Fine Cotton" ring-in enquiry and subsequent appeals by Robbie Waterhouse to lift warnings-off.

He has an extensive knowledge of the mining industry, and has represented the colliery proprietors in the Judicial Inquiries into the Appin Mine disaster and the West Wallsend Mine explosion. He also appeared for the New South Wales Water Board in the Reynolds Commission of Enquiry into mining under stored water.

Other Enquiries and Royal Commissions in which he has appeared include the Gyles Royal Commission into the building industry (for Lend Lease), the Court of Marine Enquiry into the burning of the tanker "Cellana" (for Shell Oil), and he represented the joint venturers in the Enquiry into the 2003 Canberra bushfires. He has also appeared both as counsel assisting and on behalf of parties in various Independent Commission Against Corruption (ICAC) hearings. In addition to being admitted at the New South Wales Bar, he is also admitted in the Australian Capital Territory, South Australia, Western Australia, Queensland, Victoria and the Republic of Ireland. Prior to coming to the Bar, he was the Associate to Justice David Selby and also to Sir Kenneth Manning.
